


Instructions for students for PG Admission – NEET 2021-22

AIQ-2 Round

- 1) All the students should follow the Covid appropriate behaviour such as use of Mask & Use of Sanitizer.
- 2) Students should have Negative RTPCR report of Covid test done within last 72 Hrs.
- 3) Students should attach Second/Booster Dose Certificate with admission form.
- 4) Students should bring a folder file at the time of admission.
- 5) The Folder file should have a Sticker denoting students Name, Dept. Name, Student Whatsapp Number, Email-Id, Date of Admission and Year of Admission.
- 6) Students should not change the Email-ID and Whatsapp number mentioned on the folder file.
- 7) User name and password received on this mobile number and Email-ID should be preserved by the students until they passed out their final examination.
- 8) At the time of admission, Original Certificate and two self attested Xerox copies of the Original Certificate has to be submitted to the PG section.
- 9) Original Certificate should be Colour Scanned in pdf format (size should be upto 125 kb). All these certificates should be submitted in a Pen drive to the PG section.
- 10) All the Original Scanned document in the pdf format should be preserved in pen drive as well as on Google drive till the completion of PG bond. As no Original documents or Xerox will be provided by the office.
- 11) At the time of admission, all PG students should pay RS. 1500/- in cash as admission fee in the Cash Section of office.
- 12) Tuition fee and other fee Total Rs. 1,20,400/- Cheque in favour of “**The Dean, Govt. Medical Collge, Miraj**” payable at Miraj should be given at the time of admission.
- 13) At the time of admission 3 latest Passport size photographs are required.
- 14) Students who wish to retain their seat have to submit retention form in 3 copies.
- 15) At the time of admission, student should bring selection/allotment letter in 4 Copies available on [www.mcc.in](http://www.mcc.in) and or [www.mahacet.org.in](http://www.mahacet.org.in).
- 16) Students should submit fully completed admission form available on [www.gmcmiraj.edu.in](http://www.gmcmiraj.edu.in) website of Govt. Medical College, Miraj at the time of admission.
